Dear parents and students,

We are excited to once again provide a Bible camp experience for our 9<sup>th</sup>-12<sup>th</sup> grade students. This year we will enjoy Timber Ridge Bible Camp (759 Timber Ridge Camp Road, High View, WV, 304-756-8618). We will depart school after homeroom on Thursday, September 28 and will return by 3:30 PM on Friday, September 29. Several of our middle/high school teachers will serve as chaperones.

The camp will provide students with a special opportunity to consider their relationship with God. We will have 3 chapels to challenge students and staff in their walk with the Lord.

The cost for camp is \$85/student and covers lodging, 4 meals (Thursday lunch and dinner and Friday breakfast and lunch) and all camp activities. A snack shop and bookstore will be available, so students may want to bring some spending money.

Students should bring the following items:

- Bedding (sleeping bag or sheets/blankets)
- Pillow
- Towel
- Toiletries (toothbrush, toothpaste, soap, shampoo, deodorant, etc.)
- Sneakers (comfortable shoes)
- Bible
- Flashlight and bug spray
- Spending money for snack shop (optional)

**All students should wear their P.E. clothes to school on Thursday to wear to camp.** This includes their P.E. shirt and shorts or athletic pants. They may bring additional clothes to wear at camp. Specifically, they may bring other shorts that are the same style and length as the P.E. shorts (loose, longer, basketball style shorts) but in any color and brand. They may bring t-shirts (without objectionable words/pictures), hoodies, athletic pants (not leggings) or other (not ripped) comfortable pants. If a student wears something questionable, he will be asked to change into his P.E. uniform. Students may wish to bring an umbrella or jacket in case it rains.

Please know that students may not bring any electronic devices with the exception of a phone if you wish your child to have one. The school will bear no responsibility for lost, stolen, or damaged phones on the trip. Further, students will not be permitted to use their phones during meals, chapels or after lights out, and at no point on the bus or during the trip are earbuds/headphones permitted.
